#### 1. 申請時程 When to Apply

秋季班: 2025年03月05日至2025年07月28日(2025年9月入學)。

春季班: 2025年10月01日至2025年12月29日(2026年2月入學)。

Fall Semester: From March 5<sup>th</sup> to July 28<sup>th</sup>, 2025 (September 2025 Admission).

Spring Semester: From October 1st to December 29th, 2025 (February 2026 Admission).

#### 2. 報名方式 How to Apply

#### 3. 申請資格 Who can Apply

- (1) 具外國國籍且未曾具有中華民國國籍,於申請時並不具僑生資格者,得依外國學生來臺就學辦 法規定申請入學。
- (2) 具外國國籍並符合下列規定,且最近連續居留海外六年以上者,亦得依本辦法規定申請入學。 但擬就讀大學醫學、牙醫或中醫學系者,其連續居留年限為八年以上:
  - 申請時兼具中華民國國籍者,應自始未曾在臺設有戶籍。
  - 申請前曾兼具中華民國國籍,於申請時已不具中華民國國籍者,應自內政部許可喪失中華 民國國籍之日起至申請時已滿八年。
  - 前二款均未曾以僑生身分在臺就學,且未於當學年度經海外聯合招生委員會分發。
- (3) 依教育合作協議,由外國政府、機構或學校遊薦來臺就學之外國國民,其自始未曾在臺設有戶籍者,經主管教育行政機關核准,得不受前二項規定之限制。
- (4) 第二項所定六年、八年,以擬入學當學期起始日期(二月一日或八月一日)為終日計算之。
- (5) 第二項所稱海外,指大陸地區、香港及澳門以外之國家或地區;所稱連續居留,指外國學生每曆年在國內停留期間未逾一百二十日。連續居留海外採計期間之起迄年度非屬完整曆年者,以各該年度之採計期間內在國內停留期間未逾一百二十日予以認定。但符合下列情形之一且具相關證明文件者,不在此限;其在國內停留期間,不併入海外居留期間計算:
  - 就讀僑務主管機關舉辦之海外青年技術訓練班或教育部(以下簡稱本部)認定之技術訓練專 班。
  - 就讀本部核准得招收外國學生之各大專校院華語文中心,合計未滿二年。
  - 交換學生,其交換期間合計未滿二年。
  - 經中央目的事業主管機關許可來臺實習,實習期間合計未滿二年。
- (6) 具外國國籍並兼具中華民國國籍,且於本辦法中華民國一百年二月一日修正施行前已提出申請喪失中華民國國籍者,得依原規定申請入學,不受第二項規定之限制。
- A. A person of foreign nationality who has never held the Republic of China ("R.O.C.") nationality and who does not have overseas Chinese student status at the time of their application is permitted to apply for admission to an educational institution, by these Regulations (Regulations Regarding International Students Undertaking Studies in Taiwan).
- B. A person of foreign nationality who meets the following requirements and who has resided overseas continuously for at least six years in the immediate past is also permitted to apply for admission to an educational institution in accordance with these Regulations. However, a person who plans to apply to study in a university department of medicine, dentistry, or Chinese medicine must have resided overseas continuously for at least eight years.
  - A person who, at the time of their application, also holds dual R.O.C. nationality shall have never

- had a household registration in Taiwan.
- A person who, before the time of their application, also held dual R.O.C. nationality but no longer does at the time of their application shall have renounced their R.O.C. nationality with the approval of the Ministry of the Interior on a date at least eight full years before making their application.
- The person referred to in the preceding two subparagraphs must have never previously undertaken studies in Taiwan as an overseas Chinese student nor have accepted a placement by the University Entrance Committee for Overseas Chinese Students in the current academic year.
- C. A foreign national who was selected by a foreign government, organization, or school to study in Taiwan by the Education Cooperation Framework Agreement and who has never had a household registration in Taiwan may be given exemption from the restrictions set out in the preceding two paragraphs if the competent education administrative authority approves.
- D. The periods of six years and eight years stipulated in Paragraph 2 shall be calculated using the starting date of the semester (February 1 or August 1) as the period's end date.
- E. The term "overseas" used in Paragraph 2 refers to countries or regions other than the Mainland Area, Hong Kong, and Macau; the term "reside overseas continuously" means that an international student has stayed in Taiwan for no more than a total of 120 days in each calendar year. When calculating the number of consecutive years spent overseas, if the initial or final year of the period is not a complete calendar year, any time spent in Taiwan in the initial or final year must not exceed 120 days. However, the time that a person has spent in Taiwan is not subject to this restriction, and it is not counted when calculating how long they were in Taiwan in a particular year if the person has documentary proof that they:
  - Attended an overseas youth training course organized by the Overseas Compatriot Affairs Council or a technical professional training program accredited by the Ministry of Education.
  - > spent a total period of less than two years undertaking Chinese language classes at a Chinese language center at a university or tertiary college with Ministry of Education approval to recruit students overseas.
  - > spent less than two years in Taiwan as an exchange student or
  - > spent less than two years undertaking an internship that they came to Taiwan to undertake with the approval of the designated central competent authority.
- F. A person who held both foreign and R.O.C. nationalities and applied for annulment of their R.O.C. nationality before the date of effect of the February 1, 2011, amendment to these Regulations may apply for admission as an international student by the provisions in place before the amendment and is not subject to the restrictions set out in Paragraph 2.
- (7) 具外國國籍,兼具香港或澳門永久居留資格,且未曾在臺設有戶籍,申請時於香港、澳門或海外連續居留滿六年以上者,得依本辦法規定申請入學。但擬就讀大學醫學、牙醫或中醫學系者,其連續居留年限為八年以上。
- (8) 前項所稱連續居留,指每曆年在國內停留期間,合計未逾一百二十日。但符合前條第五項第一款至第四款所列情形之一且具相關證明文件者,不在此限;其在國內停留期間,不併入前項連續居留期間計算。
- (9) 曾為大陸地區人民具外國國籍且未曾在臺設有戶籍,申請時已連續居留海外六年以上者,得依本辦法規定申請入學。但擬就讀大學醫學、牙醫或中醫學系者,其連續居留年限為八年以上。
- (10) 前項所稱連續居留,指每曆年在國內停留期間,合計未逾一百二十日。但符合前條第五項第一款至第四款所列情形之一且具相關證明文件者,不在此限:其在國內停留期間,不併入海外連續居留期間計算。
- (11) 第一項及第三項所定六年、八年,以擬入學當學期起始日期(二月一日或八月一日)為終日計算之。第一項至第四項所定海外,準用前條第五項規定。
- G. An applicant of foreign nationality who is eligible for permanent residence in Hong Kong or Macao, who has never had a household registration in Taiwan, and who at the time of their application has resided in Hong Kong, Macao, or elsewhere overseas continuously for at least six years may apply for admission by the provisions of these Regulations. However, a person who plans to apply to study in a university department of medicine, dentistry, or Chinese medicine must have resided overseas continuously for at least eight years.
- H. The preceding paragraph's term "resided [...] continuously" means that a person did not spend more than 120 days in Taiwan in each calendar year. However, this restriction does not apply if a person can present documentary proof that any circumstances listed in Paragraph 5, Subparagraphs 1 to 4 of the

- previous article apply. The time they spent in Taiwan in the ways listed is not counted when calculating the period of continuous residence referred to in the previous paragraph.
- I. A person who was formerly from the Mainland Area who has foreign nationality and has never had a household registration in Taiwan, and who, at the time of their application, has resided overseas continuously for at least six years may apply for admission to an educational institution, by the provisions of these Regulations. However, a person who plans to apply to study in a university department of medicine, dentistry, or Chinese medicine must have resided overseas continuously for at least eight years.
- J. The preceding paragraph's term "resided [ ...] continuously" means that a person did not spend more than 120 days in Taiwan in each calendar year. However, this restriction does not apply if a person can present documentary proof that any circumstances listed in Paragraph 5, Subparagraphs 1 to 4 of the previous article apply. The time they spent in Taiwan in the ways listed is not counted when calculating the period; they resided continuously overseas, as referred to in the previous paragraph.
- K. The periods of six years and eight years stipulated in Paragraph 1 and in Paragraph 3 shall be calculated using the starting date of the semester (February 1<sup>st</sup> or August 1<sup>st</sup>) as the period's end date. The definition of "overseas" in Paragraph 5 of the previous article also applies mutatis mutandis to Paragraphs 1 to 4.
- (12) 外國學生依前二條規定申請來臺就學,以一次為限。於完成申請就學學校學程後,除申請碩士 班以上學程,得逕依各校規定辦理外,如繼續在臺就學者,其入學方式應與我國內一般學生相 同。
- L. An international student applying to study at an educational institution in Taiwan by the provisions of the two previous articles is limited to only applying once [English note: a person may apply to more than one educational institution, but if one of these applications is successful and they then study in Taiwan, they cannot subsequently apply to study at another educational institution for a course at that level]. After completing the course of study at the educational institution to which they applied, unless the student is applying for admission to a program for a master's degree or a higher degree, which each university may handle in accordance with its regulations if the students want to continue studying in Taiwan, their application shall be handled in the same manner as the admission procedures for domestic students.

- (14) 外國學生具備以下各款學歷之一,且符合前述身分規定者,得申請入學本校修讀學位:
  - 具有符合教育部「大學辦理國外學歷採認辦法」、「大陸地區學歷採認辦法」或「香港澳門學歷檢覈及採認辦法」規定之學歷。申請學士班新生須具高中畢業學歷、申請碩士班者須具及士畢業學歷。
  - 具有教育部「入學大學同等學力認定標準」有關該學制 同等學力報考資格者。
  - 持國外或香港、澳門學歷,其報考學歷須另符合教育部「入學大學同等學力認定標準」第9條之相關規定。
- N. An international student who have one of the following academic qualifications and meet the aforementioned status requirements may apply for admission to a degree:
  - Possessing qualifications in accordance with the Ministry of Education's "Measures for Accepting Foreign Educational Qualifications by Universities," "Measures for Accepting Overseas Educational Qualifications in Mainland China," or "Hong Kong and Macau Educational Qualifications and Admissions Regulations." Applying for a bachelor's program requires a high school diploma, a master's program requires a college graduation degree, and a Ph.D. program requires a master's degree.
  - Those who have qualification requirements for equivalent academic abilities in the academic system of the "Equivalent Academic Ability Recognition Standard for Admission Universities" of the Ministry of Education.
  - ➤ Holders of foreign or Hong Kong or Macao education qualifications must meet the relevant requirements of Article 9 of the "Education Criteria for Equivalent Academic Ability" of the

Ministry of Education.

#### 4. 語言能力規定 Language Proficiency Requirements

- (1) 本校要求進入中文授課為主的學生應有基本華語聽說讀寫能力,而進入英語授課為主的學生應有基本英語聽說讀寫能力;因此,外國學生於申請入學時得檢附已具基本聽說讀寫語言能力之相關證明,以作為入學資格審查有利之依據。
- (2) 檢附語言能力證明如下:
  - 申請全英語授課之系所:
    - 1. 英語非母語外國學生通過 CEFR 語言能力參考指標 B1(含)以上或其他英文檢定同級。
    - 2. 英語為母語者或畢業於英語授課之學校並具證明者。
  - 申請中文授課為主之系所:
    - 1. 母語非華語外國學生通過 CEFR 語言能力參考指標 A2(含)以上或其他中文檢定同級。
    - 中文為母語者或畢業於中文授課之學校並具證明者(例如:馬來西亞華文獨立中學畢業證書)或大學主修中文並具證明者。
- (3) 由於臺灣各駐外機構辦理申請來臺簽證時會要求檢附相關語言能力證明,請自行查閱當地臺灣 駐外機構之規定,以利完成簽證申請。
- A. Students who apply for a program that is taught in Chinese should be proficient in Chinese listening, speaking, reading, and writing; students who apply for a program that is taught in English should be proficient in English listening, speaking, reading, and writing. Applicants need to submit proof of language proficiency with their application.
- B. Suggested certificates of language proficiency are described below:
  - Programs taught entirely in English
    - 1. Applicants who are native speakers of the English language or graduated from a school where English is the language of instruction.
    - 2. Applicants who have achieved CEFR B1 (The Common European Framework of Reference for Languages) or above, or other English tests at the same level or above.
  - Programs taught mainly in Chinese
    - 1. Applicants who are native speakers of the Chinese language or graduated from a school where Chinese is the language of instruction (ex: Graduation certificate of Malaysia Chinese independent high school) or Chinese is the language instructed by their major in college.
    - 2. Applicants who have achieved CEFR A2 (The Common European Framework of Reference for Languages) or above or other Chinese tests at the same level.
- C. R.O.C. (Taiwan) Embassies and Missions Abroad may request applicants to submit a language certificate to apply for VISA. Please check with local embassies for relevant rules to complete the VISA application.

#### (2) 大葉大學外國學生獎助學金 Da-Yeh University (DYU) Foreign Student Scholarships

博士生可獲得學雜費全部減免及 4萬元,碩士生及大學生則可獲得學雜費之全部或部分減免。以上獎助學金金額是以一學期計算。獎助學金之獎勵期限,大學生最多四年(大學轉學生最多三年),碩士生最多二年,博士生最多三年。如學生已具有臺灣獎學金資格,則不另行補助新台幣四萬元。

Each scholarship recipient for the Ph.D. program will be exempted from paying all of tuition and miscellaneous fees and receive NT\$40,000 each semester. Each scholarship recipient for Maser and the undergraduate program will be exempted from paying all or part of tuition and miscellaneous fees. Scholarships are awarded on a semester basis. Each student seeking a Bachelor's degree may be offered a scholarship for a maximum of four years (at most three years for transfer students). Each student seeking a Master's degree may be offered a scholarship for a maximum of two years. Each student seeking a Doctor's degree may be offered a scholarship for as many as three years. NT\$40,000 will not be provided to the applicants who own the Taiwan Scholarship.

A health certificate is required, which is dated within the past 3 months and contains a Serological Test for HIV Antibody, a Chest X-ray for Tuberculosis, a Stool examination for parasites including Entamoeba histolytica, a Serological Test for Syphilis, proof of positive measles and rubella antibody titers or measles and rubella vaccination certificates, and examination for HANSEN'S disease.



- (2) 依教育部規定,凡曾遭國內大專校院退學者,不得再向本校申請入學,若違反此規定並經查證屬實者,撤銷其入學資格。
  - By Ministry of Education regulations, those expelled from any university or college in the Republic of China are not eligible to apply to Da-Yeh University for admission. Violation of the regulation will result in immediate revocation of DYU student status.
- (3) 大部分學士班課程皆以中文授課,申請人應具備華語文聽、說、讀、寫能力;研究所課程的語文要求因系所而異。
  - Most of our undergraduate courses are taught in Chinese. Applicants should possess adequate listening, reading, speaking, and writing proficiency in Chinese at a level necessary for university academic pursuit. For graduate programs, requirements for language proficiency diverge.
- (4) 已報名或錄取之學生,如經發現申請資格不符規定或所繳交之證件有變造、偽造、假借、冒用 等不實情形,未入學者即取消錄取資格,已入學者開除學籍,亦不發給任何學歷證明,如在本 校畢業後始發現者,除勒令撤銷其學位證書外,並公告取消其畢業資格。
  - Admission shall be revoked, and/or the student shall be dismissed from DYU if any information provided in his/her application or supporting documents is falsified. Those who have graduated shall have their diploma revoked.
- (5) 本申請入學係依據「大葉大學外國學生入學招生要點」辦理。
  International student applications are handled by "DYU Regulations Governing Foreign Student Admission".
- (6) 本校沒有委託任何仲介參與招生活動。
  No agency is allowed to be responsible for admissions to DYU.
- (7) 就讀國際專修部之學生,需於一年內達到華語文能力A2等級,否則將會被處以退學處分。 Students enrolled in the International Specialized Program must achieve A2 level proficiency in Chinese within one year; otherwise, they will face expulsion.
